



2017-2018 Returning Scholar Agreement

I understand that receipt of the award is contingent upon all of the following:

- 1) I will keep CBF informed of any changes to my home and campus mailing address, e-mail address, and phone numbers.
- 2) I will inform CBF of any changes in my enrollment status, including withdrawal or transfer, prior to making the change. I understand that my eligibility may change in the event that I transfer schools mid-year.
- 3) I will maintain a cumulative grade point average of at least 2.0.
- 4) I will maintain full-time enrollment status, earning at least 12 credits per semester.
- 5) I will meet all CBF deadlines. If I am not able to meet a deadline, I will e-mail or call CBF before the deadline to explain the lateness and the steps I am taking to rectify the situation.
- 6) **No later than January 15, 2018**, I will send the following: (1) a copy of my unofficial transcript that includes my Fall 2017 grades and (2) a copy of my Spring 2018 schedule.
- 7) **No later than June 15, 2018**, I will send the following: (1) a copy of my unofficial transcript that includes my Spring 2018 grades; (2) 2018-2019 Student Aid Report; (3) 2018-2019 Financial Aid Award Letter; (4) a copy of 2018-2019 Maryland Higher Education Commission awards; (5) Scholar Profile and (6) proof of completing at least ten (10) hours of volunteer service.

Terms of Grant Disbursement

CBF distributes grant money on a semester basis. The fall semester award (one-half of the grant or scholarship) will be sent to the college after CBF has received verification of your full-time enrollment from the Office of the Registrar. The spring semester award (one-half of the grant or scholarship) will be sent to the college upon receipt of your fall semester grades and verification of your enrollment from the Office of the Registrar. If you transfer mid-year, your grant will be re-evaluated and may result in an adjustment of the award.

Disclaimer

I give CBF permission to discuss my financial, enrollment, grade, and any other relevant information with my parent or legal guardian at any time.
